• Transition period:

- a. All existing certificates with old ITE standards will be remain effective before the original expired dates .
- b. It' s acceptable to apply or renew certificates with old standards till 2023/12/31, and the certificates will be effective before expired dates .
- Since 2024/1/1, the date for compulsorily implemented,
 - a. For ITE products, only acceptable to apply or renew certificates with new standards: CNS 15598-1 and CNS 15936.
 - b. For Battery Chargers, only acceptable to apply or renew certificates with new standards: CNS 15425-1 and CNS 15936.
 - c. All application for adding components < design alteration must be processed along with new ITE/Battery charger standards revision.

• Implementation:

a. New application of BSMI will be applied and evaluated based on CNS15598-1+CNS15936 since April of 2022.

ex: New models: NSP-1600 \ LRS-450/600

- b. BSMI certificates renewal will be applied with CNS15598-1+CNS15936 since 2022.
 - ex: 9 certificates of LRS family will be expired in2022 :
